Meeting Called to Order: 6:00pm

- Motion: Request to approve Minutes of January 24, 2023
  - Edit in President's Report: Recommendations for CEHD dean's search and committee vacancies sent to Provost office
    - Change approved
  - Minutes approved by majority vote
- President's Report
  - Stephanie Fiore and Lori Salem will come to RFS meeting to discuss how AI can be used in classrooms
  - Temple Press Advisory Board discussing AI: Scholars can now use AI to write books
  - Jeff Doshna TAUP President requested Faculty Senate issue a statement on academic freedom

## Jeff Solow and Kimmika will discuss and bring something back to the committee for further discussion

- CLA faculty sent letter to Senate pertaining to NTT dismissals and non-renewals of contracts. Requested Faculty Senate to investigate and gather data on workload policies across university
  - Per contract Workload policy falls under TAUP and Collegial Assembly and deans
  - Committee engaged in a discussion on processes for contract renewal across colleges
  - Committee did not see a need to pursue this further
- University morale is low. Social justice issues, high-profile transitions and budget concerns
  - Question Why do we not have Ambler reps on senate?
  - Motion: Faculty Senate grants Senate president permission to explore seeking campus representatives from Rome, Ambler and Harrisburg to be on Faculty Senate.

## • Opposed – 1; No abstentions; Motion carries by majority vote

- COVID 19 University not tracking cases and students not required to report COVID status
- PA Leadership Universities in high deficit. Lincoln U considering adding voting adjunct faculty members to the board of trustees.
- Temple Board of Trustees still considering how to have a non-voting faculty member on BoT
- Contingent Faculty and shared governance VP asked to check in on progress on contingent faculty and shared governance progress – how can we be inclusive of contingent faculty in shared governance?
- Faculty Senate president asked for a list of adjunct faculty to include in mailings at start of semester. Provost office evaluating how FS can get the list
- Penn State has FT reporter on staff. Question raised: Should TU explore the addition of additional staff for Faculty Herald? No further discussion was raised on this issue.
- Units in university have been asked to reduce budgets by various percentages to compensate for 65-million-dollar deficit
- Vice-President's Report
  - Candidates for International Programs Di Liu and Eric Borguet
    - Unanimous approval
  - Candidate for Status of Faculty of Color Kimmika Williams-Witherspoon
    - Unanimous approval
  - o FSSAOS Award recommendations will be submitted to the Cheryl Mack by February 8
- Guest: Jason Norris
  - Started with background of how he uses AI in the past and the professional organizations with which he is associated
  - Al is not new. Has been part of our daily lives (Google, Siri, Alexa, etc)
  - Presentation on AI (See enclosed PDF of presentation)
    - Al is here to stay so best to incorporate into teaching
    - Al used in Creative Space (art generators, music composers, writing tools, video editors)
    - Pros of using in academic environment: speed, accessibility, inspiration, costeffective
    - Cons of using in academic environment: lack of originality, technical limitations

       rendering colors, etc., lack of control limited range of customization, quality
    - Links to AI resources shared with committee
    - Sidenote: Text for presentation used was created using AI
  - Demonstrated ChatGPT
    - Does not pull from the Internet. Content / learning based on user input
    - Shared examples of script creation using AI
    - Presenter summary: can share general information but specifics and minute detail missing. Expertise necessary to decipher and interpret
  - Demonstrated DALL.E
    - Image generation based on a song was creative
  - Demonstrated cactus.ai

- Many tools for student use in completing assignments
- New Career Opportunity may exist in training folks to ask the most effective text-based questions in an AI
- Questions
  - How does AI generated content not violate university plagiarism policies?
    - It most likely violates university's policy on plagiarism
    - OpenAI has a tester app to see if it is AI generated or not. Testing tool could not recognize AI-generated content with consistency
    - Tool to assess AI usage: <u>https://gptzero.me</u>
  - Conversation ongoing on what percentage of change needs to be made for it to be considered "original" work
  - How effectively can it cite in APA, MLA, etc?
    - Cactus.ai has some capability
    - ChatGPT will have access to internet in 1 year
    - Microsoft investing 10billion into ChatGPT
  - ChaptGPT embedded into Microsoft Teams

  - Request for chair of Personnel Committee Tenured Professor required
    - Shohreh, Barry and Rafael will discuss and respond to Kimmika with recommendations by 2/15/2023
