 - Approved by unanimous consent
- Guests:
 - Slava Rom, Chair, Research Programs and Policy Committee (RPPC)
 - Tenure on committee is currently 5 years
 - Working to figure out role of RPPC Evaluating role in OVPR in the future
 - Distributed grant seed money to research faculty based on money granted by Faculty Senate
 - Reported that some recipients were able to use the funds to gather research data and may generate publications
 - Plans to propose suggestion for each school to have a representative on RPPC
 - Questions:
 - Who received funding?
 - o Faculty from: CST, Fox, CPH
 - How are reviews conducted? How diverse is the review committee?
 - Previous year was dry-run. Only relied on expertise of members on committee. Goal to have representatives from other colleges will help address this issue.
 - Will help if Temple has database of faculty with skills, interests and resources
 - Database may exist in OVPR. Provost's office also working on comparable database.
 - RPPC seeking other ways to contribute to the research agenda of the university

- o Jay Sinha, Chair, Faculty Senate Library Committee
 - Representation from various schools and colleges
 - Committee meets monthly Dean Lucia supportive and engaged in the committee meetings
 - Committee functions in advisory, consultative and interpretative roles
 - Achievements Textbook Affordability Project (Center for Scholarly Publishing);
 Improving Library User Experience;
 - Students have noted that sound and congestion is sometimes a problem in the library
 - Committee also populated by members of the library units
 - Chair will make request for library to be more communicative on new items at the library
 - Questions
 - How quickly does the BookBot handle requests?
 - Wait time is short
 - Are there current librarians on the committee?
 - No FT librarians on the committee
 - Are there plans to bring back library events?
 - Will make suggestions to committee. Chair encouraged to place events on university calendar
 - What will be the summer hours?
 - Need to check to verify
- o Jeff Boles, Chair, University Honors Program Oversight Committee
 - Committee has been fairly active. Meets 3 times each semester (virtual or inperson).
 - Examples of issues committee address:
 - Work with honors to create strategic plan that aligns with university strategic plan. Honors has great ideas with limited resources.
 - GPA requirements for honors students Asking critical questions around the significance and importance of using GPA as determining factor in student membership
 - Questions
 - What is the incoming average GPA?
 - o Around 3.6
 - Critical question How can Honors connect with whole university and not seem elitist?
 - When can a student join Honors a student in a later semester of their journey?
 - What are the factors being considered in admission to Honors?
 - Currently mainly just the GPA
 - What are the demographics?
 - Number of non-White students has increased
 - Jeff will get data from director of Honors on what is the increase and possible reason for increase

- Has the decrease in university admissions resulted in decrease in honors admission?
 - No significant drop-off noted. Data will be obtained and distributed
- How are applications reviewed?
 - Process is collaborative between Admissions and Director.
 Director can make recommendations to Admissions.
- What is the process to invite more faculty to teach Honors courses?
 - Process is more formalized. Presentation made at recent meeting of chairs in CLA.
- How can students take non-Honors courses for Honors credit?
 - There is an agreement/contract made between the student, faculty and Honors program
- What is the possibility of opening up admission to Honors at a later stage in college career?
 - The current structure make that difficult as Honors is designed to have students take core in Honors classes
- Sherri Hope Culver, Chair, International Programs Committee
 - First year as chair
 - Goals Keep group on track and think ahead to future activities
 - Global Temple Conference Major accomplishment. Committee on track to be more involved with Global Engagement and the conference. Conference was successful.
 - Discussions on Temple's role in supporting scholars who are at risk (non-US scholars who are at risk/ in need). Consideration around creating a proposal for a more institutional approach for supporting scholars.
 - Temple joined the Scholars at Risk organization
 - Need to create a strategic plan for group
 - Questions
 - What discussions have there been on the committee on opening up opportunities for students to study abroad (transfer and science)?
 - Nothing prevents transfer students from traveling. The challenge is in the schedule. Will take to the committee to discuss further – maybe speak directly to transfer students.
 - What is the vision/role with respect to attracting more international students? How can we streamline the process?
 - The coordination of the engaging multiple international efforts is challenging
 - How can help be given to faculty to start the process?
 - Maybe a forum to educate faculty on how to establish relationships and learn best practices
 - How does Temple currently evaluate where relationships should be established?
 - International Educators Academy coming back in fall 2023

- Creation of a database on all programs
- Establishment of a Fulbright coordinator duties/roles
- New Business
 - Discussion on RPPC and how it selected recipients of seed grants. FSSC members expressed feeling excluded when presenter outlined the members of the committees
 - Lecture and Forums Committee Chair is stepping down. Need to revisit the role and intention of the committee. Range of applications not expansive.
 - There may be some money outstanding
 - There were some approvals for \$500
 - Updated process made things more difficult
 - Suggestion to create more opportunities for discussion between the Lectures and Forums Committee and other committees that host events
