- Motion: Request to approve Minutes of October 11
 - Unanimously approved
- President's Report
 - o Penn State and Pitt of Faculty Leadership Consortium met with Kimmika and Shohreh
 - Concerns around election. Interest groups against stem-cell research.
 - Plan to meet with the group again in November along with FSSC Executive Team
 - FSSC Executive Team met with Provost on Wednesday 10/19
 - Discussion about budgets Challenges coming down the pike
 - Students down to 33,600
 - 44 million deficit due to significantly reduced student population
 - Possible discussion on merging schools and colleges
 - Discussion on equity in NTT load and responsibilities. NTTs who are not paid equitably are those who are from marginalized communities.
 Provost's main focus and concern on students and faculty
 - Dustin Kidd sponsored resolution for class amendment for election day. Law School passed resolution to cancel classes for Election Day
- Guest: Gianni Quattrocchi, TSG President
 - Faculty members introduced themselves
 - Updates:
 - SEPTA Program/UPass Purchase key cards in bulk to distribute to faculty and students. Includes all SEPTA transport modes. Subsidies may differ depending on mode and location.
 - Voting Day as part of the discussion for the future. Too late for current year
 - Campus Safety Important. Working with Campus Safety to expand reach of TUalerts

- Restructuring in TSG resulted in scale-down of positions. Student engagement and outreach.
- Delegation of students go to Harrisburg to encourage senators to vote in favor of appropriations for Temple
- Ask: Election Day calendar amendment would be area of support from FSSC. Late for this semester can faculty independently give permission to miss class?
- Student Parliament (representatives from schools and colleges) Many seats left unfilled; never had a full parliament. New constitution of TSG is provisional. Parliament dissolved. Parliament non-functional. New constitution to be drafted to take effect during swearing-in in 2023.
- Question: Is student voice still present?
 - Engagement is higher in this administration as there were various gaps in the previous approach
- Question: Is TSG discussing divestment from fossil fuels?
 - TSG met with Temple student coalition focusing on sustainability and divestment. Talks ongoing. TSG will sign-on once group moves efforts forward with administration.
- Question: How can we get students to get to serve of the EPPC?
 - Gianni will get names to FSSC by end of week
- FSSC can collaborate on UPass, Election Day Calendar Change, Fossil Fuel Divestment and Increased Appropriations
