1. Call to Order:

2. Approval of minutes:

3. Guest: Bradley Smutek, President, Temple Student Government

After introductions and some background information about himself, Bradley was asked to discuss some of the TSG initiatives and what the Faculty Senate might be able to assist TSG with.

Some of the issues that TSG are currently working on:

- Mental health: TSG advocating for Wellness days each semester. Some faculty support to implement wellness days would be helpful.
- Muslim prayer space on campus: currently no private place for Muslims.
 Christians and Jewish faiths have support from private sources and private locations. We have a donor base but need institutional support for it.
- Campus safety: recently did a survey among students regarding campus safety concerns and shared the results with Campus Safety Services who will use to update its services.
- Basic needs: Cherry Wardrobe, much like Cherry Pantry but with clothing.
 Students may donate and receive clothes needed. Need one centralized place for students to donate and receive.
- Sustainability: students want Temple University to become a national modal of how an urban campus can operate sustainably.
- Upass: include Septa Upass in tuition. Office of sustainability has been advocating for this for some time.

- Community engagement: dialog with the North Philadelphia community, making them feel heard rather than just consulting with then moving on (?). One avenue, is a community advisory board, working with block captains, ward leaders to work on issues and make recommendations to the president and provost, etc.
