1. Call to Order Meeting began at 1:00 pm. Guests were in attendance

The Deans explained that news of the closure of University of the Arts was sudden and the news story about the closing was the first time students heard about their school's issues.

The Deans indicated that everything moved quickly after May 31, 2024. Multiple processes happened at once about transfer of students from UArts to Temple, as well as teach out agreements for students who would have been seniors in fall 2024 at UArts.

The provost was directly involved. A form for prospective transfers was put up on Temple's website very quickly. University arranged to get UArts student transcripts – and it worked shockingly fast. Expedited a new degree program in Tyler (illustration) planned for fall 2025 launch - now taking place in fall 24.

Both colleges' staff and employees stepped up over the summer. Some programs adjusted. Only a handful of faculty from UArts were hired by either college. Boyer hired three academic advisors from UArts and that helped a lot.

The Deans learned from this experience that none/few of these students had applied to Temple. Thought it was too big for them, communities are tight knit within a larger institution. We are not marketing ourselves accurately to prospective students.

The Deans said they have not been involved in discussions about acquiring UArts buildings.

Noted that UArts SFF forms are better than ours. We should send an example to Jodi Laufgraben in the Provost's office.

Discussion about publicizing this good news. The student newspaper, *The Temple News*, has been writing about it. The Faculty Herald should run a story. There is also an article by the President of the Arts Alliance. Can we get this sent to us?

The remarks by the Deans illustrated what a thoughtful, fast and efficient job Temple, both central administration and the staff in Boyer and Tyler, did in helping the UArts students transition smoothly to main campus.

4. President's Report: Shohreh Amini

The President's office moved the time of the celebration of President Richard Englert on October 23rd to begin at 1:00 p.m., so our representative faculty senate meeting can take place at 1:45 p.m. Guests will be Board of Trustees Chair Mitch Morgan and Trustee Bret Perkins. Talking with the Trustees about the new president before he arrives in November is important.
