Motion to Amend the Temple University Academic Calendar to Create a Civic Wellness Day to be Held Annually on Election Day

# Premises

- Whereas opportunity, discovery, and engagement are core values of Temple University, as stated in our mission statement;
- Whereas Temple University encourages students to engage in proactive and intentional efforts to build connections and relationships with their residential community;
- Whereas a petition for this change was signed by over 4,350 (4,387) people, including
  - o 4,066 students,
  - o 135 faculty,
  - $\circ$  47 staff, and
  - 71 alumni, including State Representative Malcolm Kenyatta; Councilmember Isaiah Thomas; President of the Temple Law Alumni Association Vanessa McGrath; The Administrative Director and Co-Presidents of the nonpartisan Bucks County League of Women Voters; Leaders of Project HOME; The Executive Director of Hillel; Dr. Eddie Glaude; and Community members, parents, and family members;
- Whereas 47% of youth with college experience said the reason they did not vote was because they had a conflict on Election Day;
- Whereas 62% of young people believe that they have the potential to impact the world, and 83% believe they have the power to change the country;
- Whereas Philadelphia needs over 8500 poll-workers;
- Whereas in the area surrounding Temple University, three of the six polling locations available to residents do not offer parking, and only two offer handicap parking, according to Philadelphia Votes' list of polling places in Philadelphia;
- Whereas Temple University and its students can provide an unparalleled value to families in the region and serve as an essential resource to the surrounding community, as stated in our mission statement; and
- Whereas Temple University can realize President Wingard's goal to "create a culture where we are open and willing to try NEW things, SAFELY fail, and innovate through that LEARNING!"

The Temple University Faculty Senate calls for the Temple University administration to amend the academic calendar to create a Civic Wellness Day to be held every year on election day.
