

University Faculty Senate Meeting
Wednesday, April 14, 2021 - 1:45 pm

Meeting Minutes

Attendance: Fifty-seven (57) faculty, librarians, and administrators in virtual attendance
Guest: Richard M. Englert, University President

1. Call to Order

The President of the Senate called the meeting to order at 1:45 PM and welcomed the assembly.

2. Approval of Minutes of December 8, 2020

The President asked for any comments, additions, or revisions to the meeting minutes. There being none a motion was made to approve the minutes. The motion was seconded, and the measure was put to a vote. The motion passed.

3. Guest: Richard M. Englert, University President

The President welcomed University President Englert. Englert's remarks included:

- Englert thanked the faculty for an amazing year.
- Englert noted the loss of Dean Daley and the significant loss this represents to the University. There will be a memorial on campus in June to honor Dean Daley's memory. President Englert and Provost Epps have met with leadership at LKSM and have asked for nominations for Interim Dean; interviews for the position are beginning today. A selection is expected in the very near future.
- Englert made comments about the impact of the pandemic. More than 100,000 people have been tested throughout the pandemic and the current positivity rate is below 1%. There are currently 5 sites for vaccinations including the Temple Health, CPH, LKSM, Black Doctors Association are utilizing Liacouras Center with our support and another location for students and community members at White Hall.
- In terms of the budget, Englert noted that the University has received federal stimulus funding. These funds have gone directly to students, loss revenues and testing, PPE, and vaccinations. On balance even after the stimulus funding Temple is still in a deficit of approximately \$72m. Summer and Fall enrollments may impact this deficit overall. Temple is very successful in graduating students in 4 years and that has an impact on the budget and a very positive impact on students. Enrollment is expected to be down overall this year. Budget cuts at the unit/school/college are being asked to plan for a 3 – 5% overall cut to the budget.
- Englert noted that despite the challenges facing Temple as a result of COVID there has been great success in terms of scholarships, fellowships, and research. In addition, Englert noted the success of our students as awardees in many national competitions.

Englert noted that faculty preparation of students has aided in their success. Englert also noted the success of our student athletes and that 91% of our athletes graduate.

- Englert also thanked the leadership of the Faculty Senate including great thanks to Rafael and Kimmika for their work on the COVID Cabinet and other critical committees.

A question and answer period followed Englert's comments and included:

- A question was asked about mandating of COVID vaccinations. At this point and due to the Emergency Use Authorization of the currently available vaccines this may not be possible. Englert noted that Temple continues to encourage everyone eligible to be vaccinated.
- A question was asked about the Confucius Institute and when the Institute will close. Englert noted that the Institute has been given a 6 month time to closing and noted again that the goals of the Institute have been met. New partnerships with other institutions in China are forming.
- A question was raised about what we have learned from the past year and the changes we have all experienced. Englert noted that faculty is best positioned to consider how program delivery has changed and what makes sense to carry forward. Englert noted that administratively we will likely be more strategic in terms of in-person meetings. Englert noted that athletics will likely change in some ways as will the more impromptu campus interactions. Englert said there will be changes but that how we change lives will likely never be 100% online.
- A question was raised about "anti-Semitic statements" made by M. Lamont Hill. Englert said that this person is one of our colleagues and as an institution we support the first amendment rights of people to express their views. Englert noted this is a complicated issue and he is respectful of the varied views on this issue.

At the conclusion of the discussion, the Faculty Senate President presented President Englert with a certificate of appreciation from the Faculty Senate Steering Committee. Englert thanked the assembly and said, "it has been an honor and a privilege to serve in this role."

4. President's Report: Rafael Porrata-Doria
